### SECTION 4 – FIRST AID MEASURES

#### 4.1 DESCRIPTION OF NECESSARY FIRST AID MEASURES:

INGESTION:

Due to the nature of the product it is unlikely that a person should ingest a wipe. In the unlikely event, rinse mouth out with water. Due to the blend of ingredients present, the manufacturer recommends that if swallowed (the liquids component of the wipe), do NOT induce vomiting. If vomiting occurs, lean patient forward or place on left side (head-down position, if possible) to maintain open airway and prevent aspiration. If irritation develops or persists or vomiting has occurred after ingestion, seek medical assistance.

EYE:

If the wipe or the liquid component comes in contact with the eyes, hold eyelids apart and flush the eye immediately with large amounts of running water. Continue flushing for at least 15 minutes or until advised to stop by a Doctor. Check for contact lenses. If there are contact lenses, these should be removed after several minutes of rinsing by the exposed person or medical personnel if it can be done easily. As the product is rated as causes serious eye irritation, after flushing, if irritation persists, seek medical assistance.

SKIN CONTACT:

The product is an alcohol hand wipe. If irritation occurs wash skin thoroughly with mild soap and water. If irritation persists, seek medical assistance.

**INHALATION:** 

. If affected, remove the patient from further exposure into fresh air, if safe to do so. If providing assistance, avoid exposure to yourself - only enter contaminated environments with adequate respiratory equipment, once environment has been assessed for flammable vapours. Once removed, lay patient down in a well-ventilated area and reassure them whilst waiting for medical assistance. If symptoms, such as dizziness or uncoordination occur, seek medical assistance. If not breathing, provide artificial respiration and seek immediate medical assistance. If unconscious, place in a recovery position and seek immediate medical assistance. If irritation develops or persists, consult a Doctor.

### PROTECTION FOR FIRST AIDERS:

If the person has ingested the product, do not use direct mouth-to-mouth resuscitation techniques. Always ensure that you are wearing gloves when dealing with first aid procedures involving chemicals and/or blood.

PERSONAL PROTECTION:

For small spills, wear Nitrile gloves, glasses/goggles, boots and full-length clothing. During routine operation for a small spill in the open a respirator is not required. However, if mists or vapours are generated, an approved organic vapour/particulate respirator is required. For large spills, or in confined spaces, a full chemically resistant body-suit is recommended and the atmosphere must be evaluated for oxygen deficiency and whether the atmosphere is flammable. If in doubt about potential oxygen deficiency, wear self-contained breathing apparatus. Never enter an environment with a flammable atmosphere.

#### 6.3 METHODS AND MATERIALS FOR CONTAINMENT AND CLEANING UP:

**CONTAINMENT:** 

Contain the spill and mechanically collect all items. Caution: The spilled product may be slippery. Be careful of static discharges and/or sparking during clean up. If there is the possibility of spills to enter drains, surface water, sewers or watercourses ensure bunding to minimise the potential for this to occur.

**CLEANING PROCEDURES:** 

Having contained the spill, as mentioned above, collect all material quickly and place in suitable containers. Be careful of static discharges and/or sparking during clean up. Use only non-sparking tools during cleaning operations. CAUTION: The spilled product may be slippery. Follow local regulations for the disposal of waste. ### 7.1 PRECAUTIONS FOR SAFE HANDLING:

**SAFE HANDLING:** 

If handling in bulk, avoid contact with the product by using appropriate protective equipment such as gloves, glasses or goggles and full-length Extinguish any potential sources of ignition before using, as flammable vapours will be generated during application. Do not leave containers in direct sunlight. Due to the possibility of pressure build up in the container, open the container with care. Avoid breathing mists or vapours. Do not smoke when handling the material. Prevent small spills and leakage to avoid slip hazards. Properly dispose of any contaminated rags or cleaning materials in order to prevent fire hazards. ENGINEERING CONTROLS: Local ventilation is recommended to minimise the potential for exposure and for the build up of flammable vapours. In the operation of certain equipment, at elevated temperatures, or in confined spaces mists or vapour may be generated and local exhaust ventilation should be provided to maintain airborne concentration levels below the nominated exposure standard and at an acceptable level that does not cause irritation.
