4. FIRST AID MEASURES

4.1 Description of Necessary First Aid Measures

Ingestion: Do not induce vomiting. Immediately remove product from the

mouth and wash out mouth with plenty of water. Obtain

immediate medical attention.

water. Take care not to rinse contaminated water into non-affected eye. Remove contact lenses, if present and safe to do so. Ensure complete irrigation of the eye by keeping the eyelids apart and away from the eye and moving the eyelids by occasionally lifting the upper and lower lids. Continue flushing until advised to stop by the Poisons Information Centre or a doctor, or at least 15 minutes. Obtain immediate

Skin: Remove contaminated clothing and wash skin thoroughly with

soap and running water. Ensure contaminated clothing is washed before re-use, or discard. If symptoms develop, seek

medical attention.

Inhalation: Remove from source of exposure. Ensure airways are clear

and have qualified person give oxygen through a face mask if breathing is difficult. If symptoms develop, seek medical

attention.
